Abstract (en)

[origin: WO2013104376A1] The invention relates to a method for displacing at least one display content (21, 31), which is provided on at least one first display unit (20, 30) in a motor vehicle, from a first display area to a second display area, in which a gesture (50), which is associated with a movement by the user, is detected spatially as a control command, wherein a start of the movement is associated with the first display area and a completion of the movement is associated with the second display area, the two display areas being independent from one another and the display content (21, 31) being displayed on the second display area after completion of the movement.
