[origin: EP2803706A1] The present invention discloses a hard coating composition and a manufacturing method thereof comprising a UV curable resin having a (meth)acryloyl functional group and a fluororesin. Also, the present invention provides a decorative film comprising a hard coating layer, a print layer, an adhesive layer and a manufacturing method thereof, wherein the hard coating layer is consisted of the hard coating composition comprising a UV curable resin having a (meth)acryloyl functional group and a fluororesin.
