[origin: WO2013117754A1] The invention relates to a device for the processing of a surface of a workpiece or for the post-treatment of a coating on the outside or the inside of a workpiece, in particular a metal workpiece, preferably a pipe, comprising a process head (2) that can be moved through the workpiece or outside of the workpiece, an optical fiber (5), means for feeding laser light (10) to the process head (2) or means for producing laser light in the process head (2), and optical means (7) arranged in the process head, which can apply the laser light (10) to the inside or the outside of the workpiece.
