Abstract (en)

[origin: WO2013131670A1] The invention relates to a method for preventing an accident or for reducing the effects of the accident for a person riding a vehicle, in particular a two-wheeler or three-wheeler. According to the invention, in a first method step (S1), information is acquired by means of a first accident-prevention system and/or a first system mitigating the effects of the accident. In a second method step (S2), the information is transmitted to a second accident-prevention system and/or to a second system mitigating the effects of the accident. In a third method step (S3), the second accident-prevention system and/or the second system mitigating the effects of the accident is preconditioned on the basis of the information. The first accident-prevention system and the second accident-prevention system are different from each other. The first accident-prevention system and the second accident-prevention system are different from each other.
