Abstract (en)  
[origin: WO2013087313A2] The invention relates to hair treatment agents containing propylene glycol diesters and protein hydrolysates but no arylated silicones. Also disclosed is the use of said agents for the treatment of hair. The invention more particularly relates to a composition for the treatment of keratin fibers which contains no arylated silicones and contains, in a cosmetic carrier: a) at least one propylene glycol diester of formula (I), in which R1 and R2 independently represent a group selected from among at least one linear saturated or unsaturated, branched saturated or unsaturated, and cyclic saturated or unsaturated C6 to C30 hydrocarbon group and/or a phenyl or a benzyl group optionally substituted with C1 to C4 alkyl groups and/or hydroxy groups and mixtures thereof at a total amount of 0.01 to 5.0 wt.% relative to the entire composition, and b) at least one protein hydrolysate and protein hydrolysate mixtures at a total amount of 0.01 to 10.0 wt.% relative to the entire composition, said composition containing no arylated silicone oils.
