Abstract (en)  
[origin: WO2013138836A1] The invention relates to a device (1) for drawing wire (5), comprising a plurality of cone pairs (2, 3, 4) arranged in a row and drawing dies (23, 33, 43) arranged between cones (21, 22, 31, 32, 41, 42) of a cone pair (2, 3, 4), wherein wire (5) being drawn extends from one cone pair (2, 3, 4) to the next cone pair (2, 3, 4). According to the invention, a motor (6, 7, 8) is provided for each cone pair (2, 3, 4) in order to drive said cone pair (2, 3, 4).
