Abstract (en)

An extraction device (210,410) for use in kitchen ventilation systems (200) is proposed. The extraction device (210,410) comprises a filter assembly (235 j ) for filtering cooking fumes (C F ) from a kitchen environment (K E2 ), the filter assembly (235 j ) comprising filter units (235 1 ,235 2 ,235 3 ,235 4 ) each one having, at opposite faces thereof, an input section for receiving the cooking fumes (C F ) and an output section for providing discard air resulting from cooking fumes (C F ) filtering. The extraction device (210,410) further comprises a hollow case (225) for supporting the filter assembly (235 j ), the case (225) having on its top (225 T ) an output opening (125 OUT ) for allowing exhaustion of the discard air. The case (225) has on its bottom (225 T ) an input opening (225 IN ) for the passage of the cooking fumes (C F ) from below the extraction device. The filter units (235 1 ,235 2 ,235 3 ,235 4 ) are arranged in succession inside the case (225) and along a longitudinal direction (Y) of the case (225), the input and output sections of each filter unit (235 1 ,235 2 ,235 3 ,235 4 ) facing said input (225 IN ) and output (125 OUT ) openings, respectively, thereby the cooking fumes (C F ) passing through said input opening (225 IN ) are intercepted and filtered by the filter units (235 1 ,235 2 ,235 3 ,235 4 ) and the corresponding discard air is exhausted through the output opening (125 OUT ). d
