[origin: CA2923785A1] The invention relates to a method and a device for producing granulates (1) which are obtained by combining the following method steps: the raw materials (2) and optionally additives (6) are intensively mixed by adding water (3) to form a mixture (4), the mixture (4) and optionally additives (6) are introduced into a granulator (11) and the mixture (4) is granulated by adding water (3) to form raw granulates (12), said raw granulates (12), water (3) and optionally additives (6) are introduced into a rolling drum (17) and the raw granulates (12) are rolled to form said granulates (1).

Die Erfindung betrifft ein Verfahren und eine Vorrichtung zur Herstellung von Granulaten (1), wobei die Granulate (1) durch eine Kombination der Verfahrensschritte: intensives Mischen von Rohstoffen (2) und gegebenenfalls Zusatzstoffen (6) unter Zugabe von Wasser (3) zu einem Gemisch (4), Einbringen des Gemisches (4) und gegebenenfalls von Zusatzstoffen (6) in einen Granulator (11) und Granulierung des Gemisches (4) unter Zugabe von Wasser (3) zu Rohgranulaten (12), Einbringen der Rohgranulate (12), Wasser (3) und gegebenenfalls von Zusatzstoffen (6) in eine Rolliertrommel (17) und Rollieren der Rohgranulate (12) zu den Granulaten (1).
