Abstract (en)
[origin: EP2848752A1] [Object] To provide a photovoltaic cell device with good construction efficiency. [Solution] A photovoltaic cell device 1 includes a pole member 22 which stands on an installation surface P, a connecting support member 25 disposed on an upper end section 22b of the pole member 22, a rail member 23 supported by the connecting support member 25, and a photovoltaic cell module 2 disposed on the rail member, wherein the pole supporting member 25 includes a lower section that covers at least a portion of an outer peripheral surface of the upper end section 22b of the pole member 22.
