Abstract (en)

[origin: WO2014006067A1] The invention relates to a method for depositing carbon dioxide from a flue gas (RG) of a combustion system. A scrubbing solution (A) with an amine-containing absorption agent (for example 20) is mixed together with ozone and/or hydrogen peroxide as an oxidizing agent for nitrite. The flue gas (RG) is brought into contact with the scrubbing solution (A) prepared in this manner, whereby carbon dioxide contained in the flue gas is absorbed, and the scrubbing solution (A) is then thermally treated, whereby the carbon dioxide is desorbed. The invention further relates to a corresponding scrubbing solution (A) with an amine-containing absorption agent (for example 20) and with ozone and/or hydrogen peroxide as an oxidizing agent for nitrite.
