Abstract (en)
[origin: EP2860295A1] Provided is a washing machine system (400) including at least washing machine (1) and washing machine information server (300) which are capable of communication via a communication network. Washing machine information server (300) includes storage (302) that stores washing operation sequence information and at least one of detergent information and softener information, and communication unit (301) that provides the information stored in storage (302) via the communication network. Washing machine (1) includes washing unit (21) that performs washing, a setting operation unit that sets an operation of washing unit (21), a communication controller that communicates with washing machine information server (300) via the communication network to obtain the information provided from washing machine information server (300), and display unit (26) that displays the information provided from the washing machine information server (300).
