Abstract (en)
A lubricating oil composition comprising a lubricating base oil having a kinematic viscosity at 100°C of 1 to 10 mm²/s, and a poly(meth)acrylate viscosity index improver containing a structural unit represented by the formula (1) in a proportion of 30 to 90 mol% and having a hydrocarbon main chain ratio of 0.18 or less: wherein R₁ represents hydrogen or a methyl group, and R₂ represents a linear or branched hydrocarbon group having a carbon number of 6 or less.
