Abstract (en)
[origin: EP2888965A1] An object of the present invention is to provide a kimono 1 which comprises a collar belt 2, a bodice belt 3, a back lining 4, a main panel 5 and an Ohashori (tuck for adjusting a length of a longer kimono) belt 6. In addition, the collar belt 2 and the bodice belt 3 are arranged parallel to each other, and each middle portion of them is connected with the back lining 4.
