[origin: ES1135784U] Device for sintering metal-containing substances, such as, for example, iron ores or manganese ores, in particular oxidic or carbonated ores, in a sintering machine (1) - with a delivery device (2) for a sintered mixture (3) containing solid fuel in a sintering band (4), - with suction boxes (5) for driving oxygen-containing process gas through the sintered mixture in three successive sections of the sintering belt, of which the first section follows the delivery device and the third section is limited by the launching end (6) of the sintering band (4), - with an accumulation conduit (7) for joining and transmitting the sintered exhaust gas produced in the suction boxes (5) of the third section and in the suction boxes (5) of the first section, - with an evacuation conduit (8) for joining and transmitting the sintered exhaust gas produced in the suction boxes (5) of the second section, - with a feedback device (9) for the transport and for the distribution of sintered exhaust gas as at least part of the process gas to the sintered mixture in the sintering band (4), preferably to the sintered mixture in the second section of the sintering band (4), - with an exhaust gas duct (10) for evacuating sintered exhaust gas from the sintering machine (1), characterized because - the feedback device (9) and - the exhaust gas duct (10) they are connected by conduits with - the accumulation conduit (7) y - the evacuation conduit (8), there being in the accumulation duct (7) and in the evacuation duct (8) switching devices which are suitable for directing sintered exhaust gas conducted in the accumulation duct (7) or in the evacuation duct (8) o inside the feedback device (9) o inside the exhaust gas duct (10).
