Abstract (en)

[origin: EP2904894A1] The present invention relates to a modular panel and structure of a double vertical hanging unit, in the form of geotextile felt pouches, for hydroponic plant or vegetable cultivation, which comprises a vertical panel with a plurality of double vertical hanging units, in the form of geotextile felt pouches for hydroponic cultivation, a structure with a plastic cover and fixed zenithal ventilation for forming a greenhouse, and the system for the construction thereof. The object of the present invention is to provide a type of vertical panel and greenhouse that is totally different from those that currently exist on the market, by virtue of a novel, simple internal structure, the main feature of which combines the advantages of various of the vertical panels and greenhouses that exist on the market, but with a smaller number of components and with greater efficiency.
