Abstract (en)

[origin: WO2014080124A1] The invention relates to a rail (3) for a false wall (1) comprising a stretched flexible membrane (5). The rail comprises a rail profile (6) defining an outer flange (7) for securing the rail (3) to a wall (4), an inner channel (17) provided with a shoulder (23) for securing the membrane (5), and an outer channel (18) between the inner channel (17) and the outer flange (7), said rail (3) also comprising a built-in lighting system (25) housed in the outer channel (18).
