Abstract (en)
[origin: WO2014091103A1] The invention relates to a method for producing solutions of sugars and alcohols from lignocellulosic biomass, comprising a pre-treatment, a step of enzymatic hydrolysis and alcoholic fermentation, a step of extracting the alcohol produced, a step of separating the solid residue, and optionally a step of washing and drying, followed by a step of baking the solid residue in a medium comprising at least one hydrated inorganic salt of formula $MX_n \cdot n'H_2O$, wherein M is a metal selected from the groups 1 to 13 of the periodic classification, X is an anion, n is a whole number between 1 and 6, and n' is between 0.5 and 12, enabling a solid fraction and a liquid fraction to be obtained, said solid fraction being then separated and subjected to either an enzymatic hydrolysis step, or steps of enzymatic hydrolysis and alcoholic fermentation.
