Abstract (en)  
[origin: WO2014090561A1] The invention relates to a surface-finished steel sheet made of carbon steel with a coating that is formed from at least one metallic corrosion protection layer (1.1) and at least one additional layer (1.2) applied with a material bond to the metallic corrosion protection layer. In order for such a steel sheet to do without organic colour-providing paint-coating, to convey a high-quality aesthetic impression and also to have a very high UV resistance, according to the invention the at least one additional layer (1.2) is a metallic layer or is formed from a metallic layer, wherein the metallic layer (1.2) is based on stainless steel, a chromium-containing and/or nickel-containing alloy, copper and/or a copper alloy. The at least one additional metallic layer (1.2) can optionally be provided with a transparent layer (1.3). A method for producing such a surface-finished steel sheet is also described and claimed.
