Abstract (en)
[origin: EP2932857A1] To provide a wet-type pet food that allows stabilization of quality by fine adjustment of mineral amounts and is superior in preference qualities. A pet food containing at least 5% by mass and no greater than 50% by mass of solids, comprising: an animal-derived protein raw material; a plant-derived protein raw material; magnesium, sodium, phosphorous and chlorine; a preference improving substance composed mainly of a chicken-derived amino acid; and water, wherein: a ratio by mass of a total content of the plant-derived protein raw material to a total content of the animal-derived protein raw material is at least 0.15; and a total content of the magnesium, the sodium, the phosphorous and the chlorine in the solids is no greater than 5% by mass in terms of element content.
