[origin: WO2014106102A1] An underreamer for increasing the diameter of a bore. The underreamer includes a substantially cylindrical body having an axial bore therein. A mandrel may extend axially through the axial bore. One or more cutter blocks are movably coupled to the body. A ratio of a height of the cutter block to a diameter of the body is between about 0.35:1 and about 0.50:1.
