Abstract (en)  
[origin: EP2942294A1] Described is a machine (1) for wrapping a food product (100) comprising a lateral surface (103), an end portion (102) and a base portion (101) which are positioned on opposite sides of the lateral surface (103) comprising a unit (13) for folding a sheet (200) of wrapping material provided with a first and a second jaw to engage the end portion (102) and the base portion of the food product (100), the first (23) and the second (24) jaw being relatively movable between a close position for retaining the food product (100) and a far position; the folding unit (13) comprises at least one brush unit (18) defining a channel (19) for the passage of the food product (100) relatively movable between a first operating position substantially at the first jaw (23) and a second operating position substantially at the second jaw (24) for smoothing the sheet (200) of wrapping material on the food product (100) when the first (23) and second (24) jaws are in the close position.
