[origin: WO2014109445A1] A method and a mobile terminal for displaying contents are provided. The method of displaying contents for pages of a mobile terminal including a display unit in which a touch panel is installed, includes: displaying a page; detecting movement of a touch input device with respect to the displayed page; and displaying the page so that the page is convexly deformed and skipped in response to the movement of the touch input device.
