Abstract (en)

[origin: WO2014118191A1] The invention relates to a method for producing a foodstuff, wherein an acid malt, a mash or a wort, a drink and/or a concentrate is added to the foodstuff or to one of the precursors; said acid malt is produced according to at least one of the following steps: (a) a first nutrient medium is prepared, and (b) said first nutrient medium is treated with lactic acid bacteria of type *Lactobacillus coryniformis* or the type *Lactobacillus backii* (DSMZ Nr. 18080) or with a mixture of lactic acid bacteria of said types; the mash or wort is produced according to at least the following steps: (o) a second nutrient medium is prepared; and (p) the acid malt is added to the second nutrient medium. The concentrate contains: the acid malt or the mash or the wort; the mass fraction of water in the concentrate is adjusted so that it is less than 35%; and the drink is produced using the acid malt, the mash, the wort and/or the concentrate.
