Abstract (en)

[origin: WO2014121886A1] The invention relates to a method and a device for producing collars (14) of packets (10) for cigarettes, wherein a preferably continuous material web (23) of a packaging material for the collars (14) is conveyed along a transport path (collar path 36). Along the transport path, one or several processing stations are arranged for processing the material web (23) with respect to one or several characteristic properties of the collars (14). In a processing station, the collars (14) are severed from the material web (23) by applying a transversely directed severing cut. The invention is characterized in that the material web (23) for the collars (14) is processed in the processing station or stations such that at least some collars (14) differ from one another with respect to at least one characteristic property.
