[origin: WO2014124635A1] The invention relates to a vehicle, in particular a military vehicle, having a monitor (2) detachably secured to a monitor holder (3), a plurality of monitor holders (3, 4, 5) being provided to which the monitor (2) can be selectively secured. Other subject matter of the invention is a method for operating a vehicle (1), in particular a military vehicle, having a monitor (2) that can be detachably secured to a monitor holder (4), the monitor (2) being selectively secured to various monitor holders (3, 4, 5) in order to create different monitor workstations.
