Abstract (en)  
[origin: EP2966721A1] To provide a non-aqueous electrolyte secondary battery capable of preventing formation of lithium on a negative electrode during charging and preventing a short circuit between positive and negative electrodes due to contraction of a separator at high temperature. A non-aqueous electrolyte secondary battery includes a negative electrode in which a negative electrode active material layer is formed on a negative electrode collector, and a positive electrode laminated on the negative electrode through a separator, in which a positive electrode active material layer is formed on a positive electrode collector. The positive electrode active material layer on a surface of a positive electrode tab drawn from the positive electrode collector has a region which extends in a drawing direction of the positive electrode tab, exceeding a leading end line of a vertically projected negative electrode active material layer opposed to the positive electrode active material layer and in which an existing amount of the positive electrode active material layer is reduced toward its leading end portion.
