Abstract (en)

[origin: WO2014173650A1] The invention relates to a radar device (1), in particular for a motor vehicle, comprising a housing having a first housing part (2) defining a receiving space (20), and having a second housing part (3) attached to the first housing part (2) and forming a cover of at least the receiving space (20). The radar device further comprises a circuit carrier (4) accommodated inside the housing (2), wherein on a first surface (40) that in the desired mounting position faces the second housing part (3), the circuit carrier (4) is provided with at least one transmit antenna means (5) for transmitting radar beams, and with at least one receive antenna means (6a, 6b) for receiving radar beams, and on a second surface (41) is provided with electronic high frequency circuit components and low frequency circuit components, and having at least one shielding means inside the housing. The shielding means is designed for an electromagnetic radiation shielding, characterized in that the shielding means comprises a one-piece shielding body (7) arranged between the first housing part (2) and the second housing part (3), and which is configured such that the shielding body (7) can encircle the electronic high frequency circuit components and low frequency circuit components.
