Abstract (en)

[origin: US2016113361A1] The invention relates to a bracelet clasp including three strips, and a cover hinged to one of the strips. The clasp is provided with first and second push-pieces and with a safety device preventing lateral movement of the cover causing the clasp to unlock when pressure is simultaneously exerted both on a push-piece and on a flap of the cover opposite said push-piece. According to the invention, the safety device includes a spacer being received between the cover flaps, the ends of the spacer abutting against the cover flaps so as to prevent lateral movement of the cover causing the clasp to unlock when pressure is simultaneously exerted both on a push-piece and on a flap of the cover opposite the push-piece.

Abstract (fr)

L'invention se rapporte à un fermoir de bracelet comprenant trois lames (1,2,3), et une chape (4) articulée à l'une des lames. Le fermoir est pourvu de premier et second pousoirs (320, 330) et d'un dispositif de sécurité empêchant le déplacement latéral de la chape conduisant à un déverrouillage du fermoir quand des pressions simultanées sont exercées sur les pousoirs. Selon l'invention, le dispositif de sécurité comprend une entretoise (23) venant se loger entre les rabats (40, 41) de la chape, les extrémités de l'entretoise venant en butée contre les rabats de la chape de façon à empêcher le déplacement latéral de la chape conduisant à un déverrouillage du fermoir quand des pressions simultanées sont exercées à la fois sur un pousoir et sur un rabat de la chape opposé au pousoir.
