Abstract (en)

An actuator arrangement comprises a primary drive member 16 located within a housing 20 and defining, with the housing 20, a first chamber 22 and a second chamber 24, a controller 26 controlling the application of fluid under pressure to the first and second chambers 22, 24 to drive the primary drive member 16 for movement, an auxiliary drive member 36 moveable between a retracted position and an extended position under the control of an auxiliary controller 44, the auxiliary controller 44 being responsive to a control pressure applied, in use, to control the pressure applied to the first chamber 22.
