Abstract (en)

A process for the production of multipage information leaflets or slips (34), especially suitable for being enclosed with products for medical-pharmaceutical or cosmetic use, said information leaflet (34) provided with a booklet structure comprising two or more pages (27) preferably in paper material and which carries the information related to the product with which they are enclosed, the process comprising in sequence the steps of: loading and feeding of a ream (24) of sheets (26) printed on one or both sides, taking of a single sheet (26) from the ream (24) and gluing along an edge portion of said single sheet (26), multiple folding of the single sheet (26) on itself along the glued portion to define a folded sheet (30), cutting of said folded sheet (30) along the opposite transversal edge portions (32) formed by the folding step to define the multipage information leaflet (34) with the pages (25) connected one to the other only at a joining area (29) in proximity of an edge, pressing of said information leaflet (34) at the joining area (29), accumulation and collection of the finished information leaflets (34) and optional rejecting of the leaflets which do not comply with the production specifications.
