[origin: US2016151698A1] Sliding board (1), whose internal structure has a core (2) edged with side ski edges (10), said core (2) separating two lower (3) and upper (4) reinforcing layers, in which core (2) includes at least additional component (20) made of material with greater flexibility than the remainder of the core, characterised in that said additional component is inserted into a slender hollow (21, 22) shaped to curve inside the core.

Planche de glisse (1), dont la structure interne comporte un noyau (2) bordé de chants latéraux (10), ledit noyau (2) séparant deux couches de renfort inférieur (3) et supérieur (4), dans lequel le noyau (2) inclut au moins élément additionnel (20) formé en un matériau présentant une souplesse supérieure au reste du noyau, caractérisée en ce que ledit élément additionnel est longiligne et incurvé par au moins une courbe réalisée dans un plan parallèle à la face inférieure de la planche.
