[origin: WO2015043641A1] The invention relates to a suction device comprising a fan device (32) for generating a suction air flow and an air conducting device (38) having at least one flow deflection element (46) comprising an inlet tube (52) and an outlet tube (54), wherein the outlet tube (54) is oriented perpendicular to the inlet tube (52) and in a transitional area (64) between the inlet tube (52) and the outlet tube (54) a sound mirror device (74) is arranged, which reflects and/or absorbs sound.
