Abstract (en)
[origin: WO2015055197A1] The invention relates to an antiperspirant cosmetic agent, containing a) at least one substance, selected from the group of cosmetic oils that are liquid at 20°C and 1.013 hPa, aromatic substances, and waxes, b) at least one antiperspirant aluminum salt in a total amount of 0.1 to 80 wt%, with respect to the total weight of the antiperspirant cosmetic agent, and c) at least one compound of formula (PP-I), wherein R1 stands for hydrogen or a linear or branched alkyl group having 1 to 6 carbon atoms, R2 and R3 stand, independently of each other, for a linear or branched alkyl group having 1 to 6 carbon atoms or R2 and R3 form a cyclic group having 4 to 8 carbon atoms and possibly a heteroatom, selected from the group of N, O, and S, and X+ stands for H+, Li+, Na+, K+, NH4+, 1/2 Mg2+, 1/2 Ca2+, 1/2 Mn2+, 1/2 Zn2+, 1/3 Al3+, 1/4 Zr4+, or at least one antiperspirant aluminum salt, wherein the addition of the at least one compound of formula (PP-I) results in effective closure formation of the excretory ducts of the sweat gland(s).
