[origin: JP2016152908A] PROBLEM TO BE SOLVED: To offer a watch band which has a wide range adjustment, can be easily attached/detached by a user and suitable for the time of playing sports. SOLUTION: A wristwatch (1) includes a watch band (3) fixed to a case (2). The watch band (3) includes an extension strand (4) and a buckle (5), the buckle (5) is structured so that it can surround the case (2) or the element projecting from the watch band (3) formed with the extension strand (4) or an additional buckle (59). The buckle (5) includes a stop surface (50), the stop surface (50) is structured so as to cooperate with a first complementary stop surface (20) of the case (2) or a second complementary stop surface (30) included by the projecting element of the watch band (3) at a fastening position. Ce bracelet (3) comporte une boucle (5) agencée pour entourer une boîte (2) ou un élément saillant dudit bracelet (3), formée par ledit brin extensible (4) ou par une boucle rapportée (59), et ladite boucle (5) comportant une surface d'arrêt (50) agencée pour coopérer, dans une position d'accrochage, avec, ou bien une première surface d'arrêt complémentaire (20) d'une dite boîte (2), ou bien avec une deuxième surface d'arrêt complémentaire (30) que comporte ledit élément saillant dudit bracelet (3).
