Abstract (en)
[origin: WO2015058834A1] The invention relates to an elastomeric body (1) for vibration damping and/or suspension, comprising a base body (2) and a flame-retarding coating (3) which covers at least one section of the base body (2), wherein the flame-retarding coating (3) comprises at least two intumescent fire protection systems and the first fire protection system contains expandable graphite which comprises at least a first fraction with an average grain size of more than 180 µm and at least a second fraction with an average grain size of less than 180 µm, and the second fire protection system forms a support structure in the expanded state, which structure at least partially fixes the expanded graphite in the expanded state.
