A support cushion is provided that makes use of a blend of materials for providing comfort and support to the body of a user. The support cushion includes a filling comprised of a plurality of fibers and a plurality of flexible foam fragments. A sleeve comprised of a flexible foam is also included in the support cushion and encapsulates the filling.
