Abstract (en)  
The method of labelling the food wrap roll consists in unwinding the label in the form of a ribbon (1) from the unwinding roller (2) and feeding it to the tensioning and perforating roller (3), which is located beneath the unwinding roller (2), the roller (3) featuring at least one bushing tube (11) with the needles (12) and puncturing perforation holes (15) along the label ribbon (1), and the label ribbon (1) is fed through a set of guide rollers (4), wound on the rolled up food wrap roll (5) and cut off crosswise. The perforation device of the labelling machine comprises the rollers (16) with bearings, mounted pivotally on the axle (13), and at least one bushing tube (11) mounted coaxially in between, with the needles (12) attached on the outer circumference and projecting out the circumference of the rollers (16), wherein the axle (13) mounted on the holders (19), attached to the frame of the labelling machine (17), is detachable. The label wound on the food wrap roll, characterised in that it features at least one row of perforation holes (15).
