Abstract (en)  
The present disclosure relates to a mounting assembly (100) for mounting an ignition device (150) to a cylinder head (12) of an internal combustion engine. The internal combustion engine includes at least one combustion chamber (14). The mounting assembly (100) comprises a cylinder head cover (4) configured to be mounted to the cylinder head (12). The cylinder head cover (4) includes a bore (24) extending along a bore axis (26). The bore (24) is fluidly connected to the at least one combustion chamber (14) via the cylinder head (12). The mounting assembly (100) further comprises a mounting flange (2) mounted to the cylinder head cover (4). The mounting flange (2) is configured to seal the bore (24) and to mount the ignition device (150). In the mounting assembly (100) at least one of the cylinder head cover (4) and the mounting flange (2) includes a venting passage (52) configured to fluidly connect the bore (24) to the atmosphere.
