Abstract (en)

[origin: EP2695647A1] The heel retainer (1) has a base (2), a heel machine (3), a ski brake (5), where a pedal (4) is movable from primary position, in which the ski brake stays distant from a ski (16) downwards, and develops a braking action, into a secondary position, in which the ski brake lies next to the ski without a braking action. A locking device is provided for the ski brake, through which the ski brake is lockable in the secondary position. Secondary locking has a locking element (13), which is connected to the pedal, and a counter-locking element (14) that is movably supported in the base.
