Abstract (en)  
[origin: WO2015082274A1] The invention relates to a domestic refrigeration appliance (1) having an interior (4, 5) which is intended for accommodating foods and is bounded by walls (3a, 3b) of an inner container (3), and having a keep-fresh container (8) for foods, which is arranged in the interior (4, 5) and has a drawer (15) and a cover (9), which is arranged for covering the drawer (15), and having a mounting device (12), by means of which the cover (9) is mounted in the interior (4, 5) such that it can be raised and lowered for opening and closing the drawer (15), and having an operating element (13), by means of which the cover (9) can be actuated, and having a partition wall (11) which is arranged in the interior (3), directly above the cover (9), and on which the operating element (13) is arranged, wherein the partition wall (11) has on an upper side (19), which is directed away from the cover (9), a display unit (24) for displaying the moisture content in the keep-fresh container (8).
