[origin: US2016244865A1] The present invention relates to a steel plate with excellent sour resistance, HAZ toughness and HAZ hardness, including, in terms of mass %, C: 0.02-0.20%, Si: 0.02-0.50%, Mn: 0.6-2.0%, P: over 0% and 0.030% or less, S: over 0% and 0.004% or less, Al: 0.010-0.08%, N: 0.001-0.01%, Nb: 0.002% or more and less than 0.05%, O: over 0% and 0.0040% or less, REM: 0.0002-0.05%, and Zr: 0.0003-0.020% with the remainder consisting of iron and inevitable impurities, in which an expression  $10,000 \times [\text{Nb}] + 31 \times \text{Di} - 82\#0$  (where  $\text{Di} = ([\text{C}]/10)0.5 \times (1 + 0.7 \times [\text{Si}]) \times (1 + 3.33 \times [\text{Mn}]) \times (1 + 0.35 \times [\text{Cu}]) \times (1 + 0.36 \times [\text{Ni}]) \times (1 + 2.16 \times [\text{Cr}]) \times (1 + 3 \times [\text{Mo}]) \times (1 + 1.75 \times [\text{V}]) \times 1.115$ ) is satisfied, and, in the composition of inclusions with 1  $\mu\text{m}$  or more width contained in steel, Zr amount is 1-40%, REM amount is 5-50%, Al amount is 3-30%, and S amount is over 0% and less than 20%.
