Abstract (en)

[origin: CN106439679A] The object of the invention is to provide a lighting device for a motor vehicle with luminescent elements. The invention relates to a lighting device (1, 2, 3) for a motor vehicle having at least one illumination formation unit comprising a light source (20, 22a) and a supplementary optical unit (10, 60) and an illumination unit (20) downstream from the illumination beam unit (30, 40, 65), the light source (20) or the additional optical unit (10, 60) comprising at least partial pigments (11, 12) of at least one luminescent material, 40, 65) homogenises the light output. The invention also relates to a motor vehicle headlamp comprising at least one lighting device according to the invention.
