[origin: WO2017009447A1] The invention relates to a cleaning tablet for removing wine residues, characterised in that it comprises hydrogen carbonate, citric acid, surfactant, bleaching agent, bleach activator and complexing agent, the common mass fraction of hydrogen carbonate and citric acid in the cleaning tablet lying at 30% - 70%, and the molar ratio of hydrogen carbonate to citric acid in the cleaning tablet lying between 1:1 and 4:1.

Die vorliegende Erfindung betrifft eine Reinigungstablette zur Entfernung von Weinrückständen, dadurch gekennzeichnet, dass sie Hydrogencarbonat, Zitronensäure, Tensid, Bleichmittel, Bleichaktivator und Komplexierungsmittel umfasst, wobei der gemeinsame Massenanteil von Hydrogencarbonat und Zitronensäure in der Reinigungstablette bei 30% - 70% liegt, und das molare Verhältnis zwischen Hydrogencarbonat und Zitronensäure in der Reinigungstablette zwischen 1:1 und 4:1 liegt.
