Abstract (en)

[origin: WO2015155457A1] The present invention relates to an item of sports equipment (1) intended to be used on a playing area, comprising a rectilinear body (2) having a central portion (3) and two end portions (4). The rectilinear body (2) extends in a longitudinal direction and has, in cross section, a section of elongate shape of which the length (L) defines, with the longitudinal direction, a main plane (P). In particular, at least one of the portions (3, 4) of said item of sports equipment (1) comprises a connecting means (5, 11) configured to keep said item of sports equipment (1) on a second item of sports equipment comprising a rectilinear body extending in a longitudinal direction and having: - a central portion and, - at least one end portion that has, in cross section, a section of elongate shape of which the length defines, with the longitudinal direction, an end portion plane, such that the main plane of said item of sports equipment is transverse to the end portion plane of said second item of sports equipment. The invention also relates to a kit comprising such an item of sports equipment (1).
