Abstract (en)

The invention relates to a coil former (2) for an electrical coil (1), - comprising a substantially cylindrical basic body (3) having a circumferential wall (4), which basic body is delimited along its axial direction (A) by a first end wall (5a) and a second end wall (5b), which is opposite the first end wall (5a), said end walls both protruding radially beyond the circumferential wall (4), - comprising a separating element (6), which is arranged axially between the two end walls (5a, 5b) and which projects radially outwards from the circumferential wall (4) so as to form a first and a second axial winding-accommodating region (9a, 9b), - wherein the separating element (6) has an aperture (17), through which the first axial winding-accommodating region (9a) is connected to the second axial winding-accommodating region (9b).
