Abstract (en)

[origin: WO2015158416A1] The invention relates to a motor vehicle (1) having a rear-view arrangement (2) with no side mirror, comprising at least one camera (3) which can capture at least part of a rearward space/traffic situation, and at least one screen (4) on which the image portion captured by the at least one camera (3) can be displayed. Essentially for the invention, the at least one screen (4) is mounted on a bracket (5) on a side door (6) that extends towards the vehicle interior, and when the side door (6) is closed the bracket (5) at least partially engages a recess (9) in the instrument panel (8).
