[origin: WO2015162042A1] The invention relates to a method for brightening dyed textiles and to the textiles thereby produced. The method is characterized by treating the materials with an aqueous liquor containing an organic peroxocarboxylic acid having a hydrophobic group, consisting of at least 5 C atoms, as the active component.
