[origin: WO2015178815A1] The present invention relates to a curing device (2) adapted for curing a resin material (4) by adding heat to the resin material (4). The curing device (2) comprises; a resistive heating element (6), a first surface (8), a second surface (10), a first edge (12), and a second edge (14). The curing device (2) is flexible. The first surface (8) of the curing device (2) is adapted to be temporary attached to at least one first object (16) during said curing.
