Abstract (en)
[origin: WO2015181191A1] The invention is directed to a housing (7) for a drug delivery device comprising a first receiving section (14) for retaining a primary drug delivery assembly (16) and a second receiving section (15) for retaining a secondary drug delivery assembly (17). A movable actuator (34) comprises a first engagement section (55) and an actuation collar (37) comprises a second engagement section (53). A setting element (35) is movable around a second longitudinal axis (5) from a first position into a second position during a setting movement (56) and drives the actuation collar (37) into engagement with the actuator (34), wherein in the first position of the setting element (35) the actuator (34) is free to move relative to the actuation collar (37) and in the second position of the setting element (35) the actuation collar (37) engages the actuator (34) such that an actuation movement (63) of the actuator (34) is transferred to the actuation collar (37). The invention is also directed to a respective drug delivery device.
