Abstract (en)

[origin: WO2015181486A1] The invention relates to a display device (10) intended for a motor vehicle passenger compartment, the display device comprising at least: a display screen (12), the display screen comprising at least three holder studs (14) disposed on the back of the display screen and a first reference point, a securing casing (16) comprising a second reference point, securing means (18), the display screen (12) being secured to the securing casing (16) as a result of the securing means (18) engaging with the holder studs (14), and characterized in that the display device (10) comprises between the back of the display screen (12) and the securing casing (16) at least one rigid shim (20), the rigid shim being configured such that the difference between the distance separating the first and second reference points and a desired dimension is as small as possible.
